



**AUTHORIZATION TO OBTAIN AND RELEASE INFORMATION**

I/We have applied for a loan or have an existing loan with **FINANCE FACTORS, LIMITED** and understand that this loan might be sold by **FINANCE FACTORS, LIMITED**.
